Trailers 15 ft and longer:

\$150 year-round

Trailers 15 ft or shorter:

\$125 year-round

Stall fees not paid on the day of the market will incur a 10% late fee, which will be added to the total vendor amount for that day.

Vendors who cancel within 72 hours of their scheduled market day will be charged the full vendor fee for that day.
